Streamlining Processes

Use standard forms, like provided, on all levels

Lead Beneficiary, Beneficiaries, Sub-Partners

Involve FLCs before corresponding

Consolidate the matching information

report unquestionable cost items only

ask and clarify before reporting

report FLC audited costs only

on accounts done, the FLC confirms

comment in cover letter

add remarks, where necessary
