Population

- Approximately 60 million
- 13 % of EU 25


Land Area

The Interreg IVB North Sea Region Programme

- Geographical diversity Finnmark (N): 1.5 inh./km² Hamburg (G): 2.293 inh./km²
- **GDP/Capita** 75-150 % EU 15 average (2002: 28.516 €)
- Unemployment
 below EU average
- SMEs

- Maritime issues is considered to be a crosscutting theme
- Maritime knowledge economies (Priority 1);
- Developing maritime spatial planning concept for the NSR (Priority 2);
- Response to maritime accidents (Priority 2);
- Support of maritime corridors (Priority 3);
- Promote harmonised and easy access to data bases on maritime transport activities (Priority 3)
- Develop sustainable tourism concepts to utilise the cultural assets, natural and built environment (Priority 4)

- Northern Maritime University (NMU):
 - Common curricula for the North Sea region oriented maritime business management programmes (B.Sc & M.Sc. level)
 - Professional accreditation of programmes and qualifications
 - NMU network





- SAWA:
 - Centres for education towards sustainable risk flood management around the North Sea
 - Adaptive strategy for implementation of flood risk management plans in the North Sea Region
 - Decision support database for flood protection measures in the North Sea Region





StratMos:

- Transnational solutions for 'invisible' inter-modal transport
- Strategies for connecting transport networks and corridors
- A system model of MoS and inter-modal transport





- Waterways 4 Growth:
 - A framework for the sustainable development of inland waterways
 - New and expanded businesses based on waterways
 - A common approach to regenerate historic waterways

Allocated Funding

- 51% of the total ERDF funding allocated
 - Still a 50% grant rate
- 67% Norwegian equivalent allocated
 - Grant rate reduced to 30%

- Oriented towards implementation
- An overall transnational approach
- Creating impact for the North Sea region
- Creating lasting results
- Contributing to the Lisbon and Gothenburg agendas
- Linking to National and European policies
- Contributing to a positive innovation orientated culture in the North Sea region





The state aid rules

- The state aid rules are old news, but ...
- Increased emphasis on state aid rules from the European Commission, which impact directly on the projects
- The state aid rules do not distinguish between public and private partners





What is state aid?

- The support must be considered as aid
- Musth be given by way of public funds this included EU funding
- Musth be selective e.g. confined by a budget
- Must distort or threaten to distort competition i.e. the beneficiary gain a competitive advantage via the support





Where does this leave you?

- All project results must be made available to the general public free of charge
- No partner can claim intellectual or physical ownership of project results
- All project partners must adhere to the public procurement rules in the context of the project
- A separate account must be opened for the project in the accounting system and it must be possible to separate project activities from other activities





First and foremost!

Take advice seriously and be honest with your private sector partners!

Have a plan B when your private sector partners drop out!
