Seminars on the Priorities of the Programme WEDNESDAY 11 JUNE 11–13

Identifying projects for the sustainable development of the North Sea Region

Each of the four seminars will consist of key presentations from experts with a relevant background on the programme priority fields. The programme secretariat and National Contact Points will also be at hand to provide general programme and priority specific information.

Within each seminar the participants will be divided into pre-selected 'area of intervention' groups, enabling the opportunity to discuss a number of key questions within a focused setting related to the area of intervention and the IVB Programme requirements. Participants can use their experiences and project ideas in order to contribute towards group discussions.

A feedback session will take place within each of the four seminars enabling the participants to inform the audience of the outcomes of the work undertaken within each of the area of intervention groups. There will also be time during this session to interactively share and promote project ideas, as well as raise any questions on the programme and/or priority issues.

Drop in Seminars

Wednesday 11 June 14-17

A number of drop-in seminars will be held during the Annual Conference. As the name indicates the seminars provide an open and interactive forum to discuss different issues in relation to project development, finance and communications for project development under the Programme.

The drop-in seminars are smaller and more intimate than the other seminars. They depend on audience interaction and focus on discussion and debate. A schedule for the session will be available at the event.

Drop-In Seminars on Project Development

New Programme – New requirements

Background

During this session the new requirements for projects being developed in the IVB North Sea Region Programme will be described from a project development perspective.

The step change in requirements from IIIB to IVB can be challenging for project applicants and the presentation will therefore outline how projects can work towards meeting these changes.

The session will help project developers to understand how they can start from the perspective of making a transnational and North Sea specific impact rather than simply working together to find out how to cooperate on a transnational level.

A presentation will be held which will provide an overview of progress made in the IVB Programme to date, identify the important requirements for projects being developed and describe how the application procedure is designed and operates in practice.

Drop-In Seminar on Finance

The seminar on finance will feature sessions addressing three main issues. Each session will start with an short presentation outlining key issues and challenges in relation to the topic, followed by a discussion in which participants are encouraged to share questions and ideas.

The following three sessions will be held on finance:

- State aid and Private sector beneficiaries
- Partnership contracts
- Reporting and 1st level control

Drop-In Seminar on Communications

Sustainability as an opportunity

The drop-in seminar on communications will focus on how to incorporate sustainability into the communications and marketing of projects. The session will feature a short presentation by a representative from the private sector marketing, followed by a workshop and discussion.

The Partner Search is a forum where project developers and stakeholders can meet and discuss project ideas and further develop potential ideas. It is a networking opportunity and a place to make connections for the future.
